Violation number(s) 1,2,3,5,6 & 7 have been dismissed.



It is ordered that the defendant shall notify the United States Attorney for this district within 30 days of any change of name, residence, or mailing address until all fines, restitution, costs, and special assessments are fully paid. If ordered to pay restitution, the defendant shall notify the court and United States Attorney of any material change in the defendant's economic circumstances. Unless modified by this judgment, all fines, restitution, costs, and special assessments previously imposed in the judgment filed on 10/14/2008 remain in full force and effect, if not already paid.

**SUPERVISED RELEASE**

It is ordered and adjudged that the offender be continued on supervised release subject to all previously imposed standard and special conditions and shall comply with the following modified/additional special condition(s):

**COOPERATION WITH THE INTERNAL REVENUE SERVICE**

You are to fully cooperate with the Internal Revenue Service by filing all delinquent or amended returns within six months of the sentence date and to timely file all future returns that come due during the period of supervision. You are to properly report all correct taxable income and claim only allowable expenses on those returns. You are to provide all appropriate documentation in support of said returns. Upon request, you are to furnish the Internal Revenue Service with information pertaining to all assets and liabilities, and you are to fully cooperate by paying all taxes, interest and penalties due, and otherwise comply with the tax laws of the United States.

The defendant shall not possess any law enforcement identification, such as Police Department, Fire Department, or Military shields or badges, that he is not authorized to possess nor may he display any such identification without prior permission of the U.S. Probation Office.

The defendant shall shut down the Bear Search and Rescue website no later than January 21, 2011 and shall not post any future non-profit web sites on the internet without prior permission of the U.S. Probation Office.

The defendant shall seek prior permission before embarking on any fund raising activities or any public speaking activities and shall provide details regarding these activities to the U.S. Probation Office.

The defendant is prohibited from selling the books entitled, Bear: America's Most Decorated Dog or Bear: Heart of a Hero while on supervised release.
